How we use trustee, member and/or governor information

We collect your information to;

- enable you to serve as a trustee, member and/or governor
- comply with our statutory safeguarding obligations
- deliver appropriate training
- effectively manage the school
- fulfil statutory reporting to the Department for Education
- to check DBS status
- fulfil statutory and/or legal requirements e.g. website, companies house

The categories of school information that we process include

- Personal information such as;
 - Name, address, contact information (e.g. email address, telephone numbers), gender, national insurance number, Employer information, Directorships, Professional Body members, business and/or third party interests and investments
- Special categories of information such as;
 - Disabilities, DBS details, occupational data.

Why we collect and use trustee, member and/or governor information

Under the General Data Protection Regulation (GDPR), the legal basis for processing personal information for general purposes are:

- Processing is necessary to comply with the legal obligations of the controller.
- Processing is necessary for tasks in the public interest or exercise of authority vested in the controller.

Our lawful basis for collecting and processing your information is also further defined under Article 9, as some of the information we process is deemed to be special categories of personal data. The following extracts from the GDPR apply;

- The data subject has given explicit consent.
- It is necessary to fulfil the obligations of controller or of data subject.
- It is in the public interest.

Collecting trustee, member and/or governor information

We collect personal information via individual Trustees, Members and/or Governors.

Trustee, Member and/or Governor data is essential for the trust's /school's / local authority's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it is requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

Storing trustee, member and/or governor information

Any information about a trustee, member and/or governing body member is kept secure and is only used for purposes directly relevant to your term as a trustee, member and/or governor at the trust/school. Once your term(s) of office with us has ended, we will retain this file and delete the information in it in accordance with our retention policy.

Who we share trustee, member and/or governor information with

We routinely share information with appropriate third parties, including:

- The Department for Education (DFE)
- Ofsted
- Police forces, courts, tribunals
- Local Authorities: Stockport Metropolitan Council, Cheshire East Council, Tameside Council and Manchester City Council
- The DBS service

- Members of the general public (via the Trust's and school's websites)

Why we share trustee, member and/or school governor information

We do not share information about our trustees, members and/or governors with anyone without consent unless the law and our policies allow us to do so.

Department for Education

We share personal data with the Department for Education (DfE) on a statutory basis. Under s.538 of the Education Act 1996, and the Academies Financial Handbook, the Secretary of State requires boards to provide certain details they hold about people involved in governance, as volunteered by individuals, and the information kept up to date.

Data collection requirements

The DfE collects and processes personal data relating to those governing schools (including single and multi academy trusts (MATs)) and all schools are required to ensure they keep their governors details up to date under s.538 of the Education Act 1996, and the Academies Financial Handbook.

Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. - object to processing of personal data that is likely to cause, or is causing, damage or distress

- claim compensation for damages caused by a breach of the Data Protection regulations
